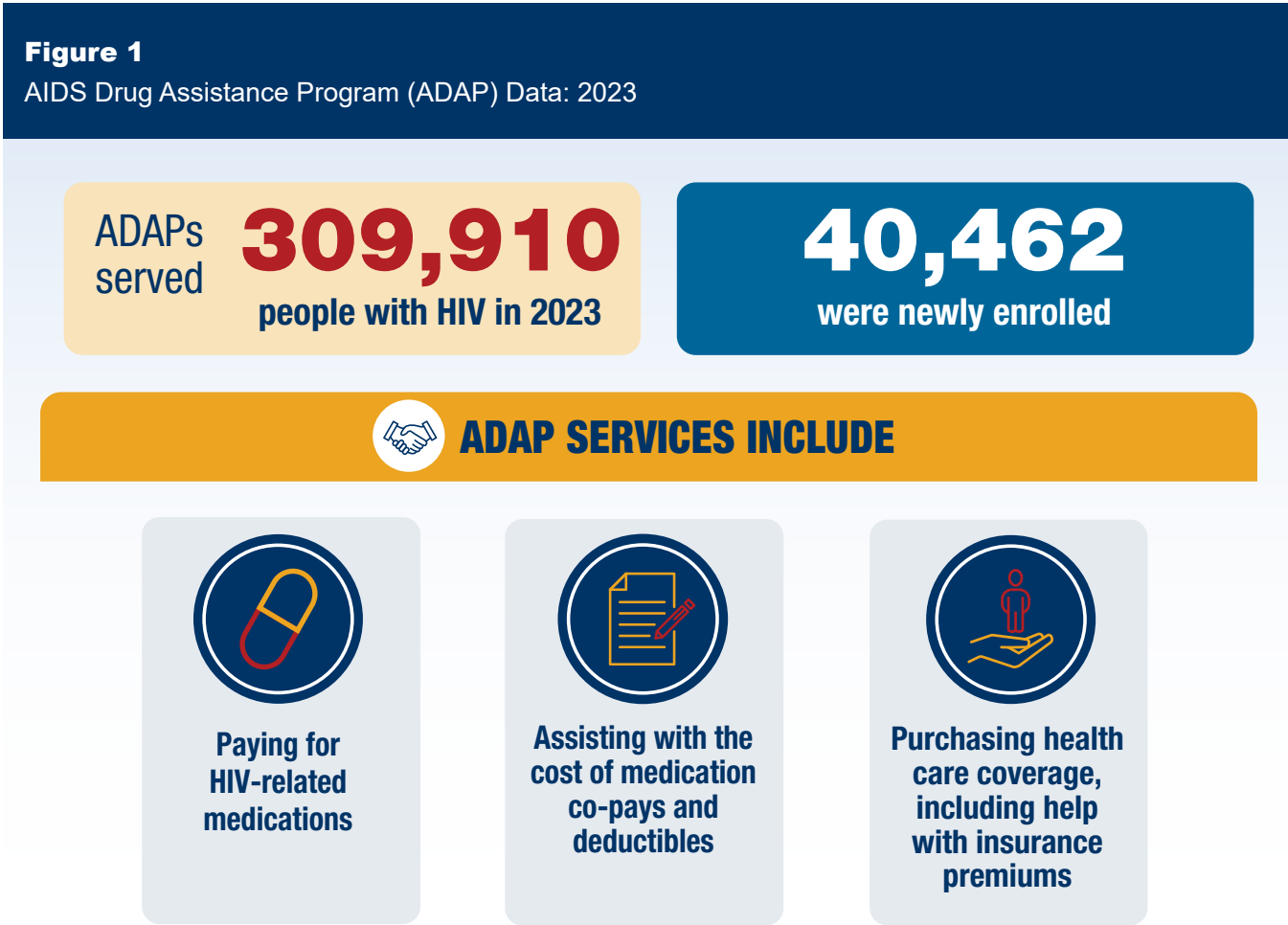
RWHAP ADAP ANNUAL DATA REPORT

INSIGHTS

The Ryan White HIV/AIDS Program (RWHAP) Part B AIDS Drug Assistance Program (ADAP) provides HIV-related medications and access to such medications through health care coverage to people with HIV who are low income and underserved. Overall, the RWHAP supports medical care, treatment, and support services for over 570,000 people with HIV.

The RWHAP Part B ADAP provides grant funding to all 50 U.S. states, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, and Pacific Island Jurisdictions. Together, the jurisdictional ADAPs served 309,910 clients in 2023, including 40,462 newly enrolled clients.

The RWHAP, including ADAP, is critical to ensuring that people with HIV are linked to and retained in care, have access to medications, and remain virally suppressed. People with HIV who take HIV medication as prescribed and reach and maintain viral suppression can manage their HIV as a chronic condition and cannot sexually transmit the virus to their partners. They can live longer and healthier lives and improve their quality of life.

WHY does the Health Resources and Services Administration (HRSA) HIV/AIDS Bureau (HAB) produce the Ryan White HIV/AIDS Program AIDS Drug Assistance Program (ADAP) Annual Data Report?

- To assess the numbers and demographics of Ryan White HIV/AIDS Program (RWHAP) clients using ADAP services.
- To measure progress toward ensuring access to HIV medications for all eligible ADAP clients.
- To evaluate the reach and impact of ADAP at the state and national levels.

WHO is included in this report?

- ADAP clients with HIV who are low income and reside in ADAP's jurisdiction.
- Newly enrolled ADAP clients.

WHAT information is presented?

- ADAP client demographic and socioeconomic characteristics, such as age, race/ethnicity, federal poverty level, and health care coverage.
- ADAP services used by clients.

WHAT geographic levels are included?

- All 50 states, the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands.
 - National data are presented in Tables 1 through 6.
 - State data are presented in Tables 7 through 12.

WHAT time periods are included?

- Calendar years 2019 through 2023, with additional details for calendar year 2023.
 - Time trend data (2019–2023) are analyzed separately for each calendar year.
 - As clients are de-identified when reported, it is not possible to link data across years.

HOW is information reported to HRSA HAB?

- Each year, ADAPs from every state, the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands report data for all eligible ADAP clients.

REPORT SUMMARY



AIDS DRUG ASSISTANCE PROGRAM OVERVIEW

The Ryan White HIV/AIDS Program (RWHAP) is administered by the U.S. Department of Health and Human Services (HHS), Health Resources and Services Administration (HRSA) HIV/AIDS Bureau (HAB). In 1990, Congress passed the Ryan White Comprehensive AIDS Resources Emergency (CARE) Act to address the crisis of the HIV epidemic in the United States. This statute was amended and reauthorized in 1996, 2000, 2006, and, most recently, in 2009 as the Ryan White HIV/AIDS Treatment Extension Act of 2009.

The RWHAP provides a comprehensive system of HIV medical care, treatment, and support services for more than 570,000 people with HIV in the United States. RWHAP legislation authorizes that a portion of RWHAP Part B funds be designated for the AIDS Drug Assistance Program (ADAP), which provides U.S. Food and Drug Administration (FDA)–approved medications and access to medications through the purchase of health care coverage for people with HIV who are low income and are underserved. HRSA HAB provides RWHAP Part B ADAP grant funding to all 50 U.S. states, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, the Northern Mariana Islands, American Samoa, Guam, Micronesia, the Marshall Islands, and Palau, hereafter referred to as state(s)/territory(ies).

Each state or territory operates an ADAP, and each is unique due to the state’s/territory’s HIV epidemic, health care coverage, and administrative structures used to ensure that medications are available to eligible people with HIV [1]. Each state/territory decides, within federal guidelines, who is eligible for the ADAP and which medications to include in its formulary [2].

The RWHAP, including ADAP, aligns with national HIV goals and the Ending the HIV Epidemic in the U.S. (EHE) initiative to reduce new HIV transmissions, expanding on RWHAP’s comprehensive system of care to focus on people with HIV who are unaware of their status and people with HIV who are not receiving regular care [3]. Building off the foundation of RWHAP and the innovative, low-barrier strategies employed in the EHE initiative, the Ryan White Program 2030 framework is designed to sustain high-quality care and treatment for people receiving services through RWHAP while expanding efforts to identify and engage people with HIV who are undiagnosed or out of care. To reflect the impact of ADAP on EHE and the Ryan White Program 2030, two data tables present newly enrolled ADAP clients showing (1) selected characteristics and ADAP services used by year and (2) the number of ADAP clients enrolled by year and state (Tables 1b and 7b).



HIGHLIGHTS OF ANALYSES

ADAP Clients

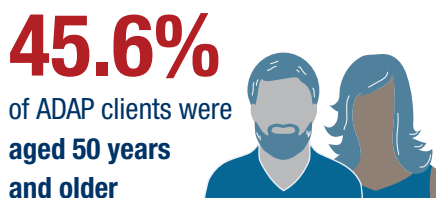
ADAPs served nearly 310,000 people with HIV in 2023. From 2019 through 2023, the total number of people with HIV enrolled in ADAP increased by about 13,000 clients, from 296,930 clients in 2019 to 309,910 clients in 2023 (Table 1a). Among those clients, 40,462 (13.1%) were newly enrolled in ADAP in 2023 (Table 1b). The total number of ADAP clients has not increased by the full number of new ADAP clients, likely due to disenrollments. Reasons for disenrollment include change in eligibility, failure to recertify, not filling prescriptions, death, or other

reasons. By state, the number of ADAP clients has varied since 2019 (Table 7a, Table 7b); these shifts may be attributed to changes to data collection, each state’s health care landscape, eligibility requirements, HIV prevention and care activities, HIV epidemiology, or clients moving to other states.

Nearly half of ADAP clients are aged 50 years or older. In 2023, ADAP clients aged 50 years or older accounted for 45.6% of all ADAP clients, an increase from 44.0% of clients in 2019 (Table 1a). By comparison, new ADAP clients in 2023 were younger than all ADAP clients. Only 22.9% of the 40,462 newly enrolled ADAP clients in 2023 were aged 50 years or older (Table 1b).



The majority of ADAP clients are male. In 2023, 79.7% of clients were male and 20.3% were female. The sex distribution of ADAP clients has remained largely consistent since 2019 (Table 1a).

Seven out of 10 ADAP clients are from racial/ethnic minority populations. In 2023, 38.0% of clients self-identified as Black/African American, 30.7% as Hispanic/Latino, and less than 2% each as Asian, people of multiple races, American Indian/Alaska Native, or Native Hawaiian/Pacific Islander. White clients represented 28.2% of all ADAP clients. These race/ethnicity distributions have remained consistent since 2019 (Table 1a).

Socioeconomic Factors Among ADAP Clients

More than three-fourths of ADAP clients are living at or below 250% of the federal poverty level (FPL). In 2023, 79.5% of ADAP clients were living at or below 250% FPL, remaining stable since 2019 (81.3%) (Table 1a). By comparison, 85.0% of newly enrolled ADAP clients in 2023 were living at or below 250% FPL, remaining stable since 2019 (85.4%) (Table 1b).

More than one-third of all ADAP clients have no health care coverage, and more than one-half of newly enrolled ADAP clients have no health care coverage. In 2023, 37.0% of ADAP clients had no health care coverage (Table 1a). Although this percentage has remained largely consistent since 2019, it varies by race/ethnicity. While 19.4% of White clients had no health care coverage, 50.2% of Hispanic/Latino clients and 39.4% of Black/African American clients had no health care coverage in 2023 (Table 2). More than half (59.6%) of newly enrolled ADAP clients had no health care coverage in 2023, only a slight increase since 2019 (58.8%) (Table 1b).

ADAP Services and Service Use

ADAP services include both full-pay medication assistance and health care coverage premium and cost-sharing assistance, which are provided to eligible clients enrolled in ADAP. All ADAP funds, regardless of their source (e.g., state funds, RWHAP Part B ADAP Base, RWHAP Part B Base, RWHAP Part B Supplemental Funding, ADAP Emergency Relief Funds, RWHAP Part A contributions, 340B rebates, ADAP Crisis Task Force rebates, program income), are reported in the HRSA HAB ADAP Data Report (ADR) [4].

Medication assistance (i.e., full-pay medication support) involves the use of ADAP funds to purchase FDA-approved medications for the treatment of HIV or for the prevention and treatment of opportunistic infections commonly associated with HIV and to support a client's retention in care.

Health care coverage assistance involves the use of ADAP funds to pay for one or more of the following:

- Full premium payment
- Partial premium payment
- Medication co-pay/deductible (including Medicare Part D coinsurance, co-payment, or donut hole coverage)

A full premium payment means the ADAP pays 100% of the client's health care coverage premium. A partial payment means the ADAP pays a portion (i.e., <100%) of the health care coverage premium. A medication co-pay/deductible means the ADAP pays the co-pay/deductible for the client's HIV-related medication, including Medicare Part D–related costs. Medication co-pays, deductibles, and coinsurance are considered ADAP health care coverage assistance services, not ADAP medication assistance services [4].

Nearly half of ADAP clients receive full-pay medication assistance.

- In 2023, 46.7% of ADAP clients used only the full-pay medication support service, while 18.4% used only the medication co-pay/deductible service, 5.7% used only the health care coverage premium assistance service, and 29.2% used multiple services (Table 1a).
- By comparison, almost three-quarters (74.6%) of newly enrolled ADAP clients used only the full-pay medication support service, 9.6% used only the medication co-pay/deductible service, 3.5% used only the health care coverage premium assistance service, and 12.3% used multiple services (Table 1b).¹

The distribution of ADAP services used varies by age.

- The percentage of clients who used only medication co-pay/deductible assistance was lowest among younger adults aged 25 to 29 years (7.3%) and higher for each older age group up to those aged 65 years and older (46.6%) (Table 6).
- The percentages of clients who used multiple ADAP services ranged from 10.8% among those aged 15 to 19 years to 36.8% among those aged 60 to 64 years, generally increasing for each older age group (Table 6).
- The distributions of the percentages of clients using only health care coverage premium assistance were low (average 5.7%) and relatively even across age groups (Table 6).

The distribution of ADAP services used differs for clients from racial and ethnic minority groups and White clients.

- Higher percentages of Black/African American and Hispanic/Latino clients used only full-pay medication support (49.5% and 63.1%, respectively), and lower percentages of Black/African American and Hispanic/Latino clients used only medication co-pay (16.9% and 10.2%, respectively) or multiple services (27.2% and 22.9%, respectively) (Table 6).
- White clients had the lowest percentage using only full-pay medication support (24.0%), the highest percentage using only medication co-pay/deductible assistance (30.1%), and the highest percentage using multiple services (39.1%) (Table 6).

¹ "Only" means a client used only one ADAP service in the reporting year; "multiple services" means a client used more than one ADAP service in the reporting year.



2023 ADAP ANNUAL DATA REPORT OVERVIEW

This report is HRSA HAB’s annual publication of national ADAP data from the ADR reporting system. It includes de-identified data for all clients enrolled in ADAP during calendar years 2019 through 2023, as submitted to HRSA by ADAPs from each of the 50 U.S. states, the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands.

- This year’s report includes new “ADAP Annual Data Report Insights” and “Report Overview” sections to provide a high-level overview of the information in the report.
- The ADR data do not include information about clients using non-ADAP RWHAP Parts A–D services, such as core medical and support services; however, many ADAP clients also use these services [5]. Data for clients using non-ADAP RWHAP Parts A–D services are reported to HRSA through the RWHAP Services Report (RSR) and are published annually in the *RWHAP Annual Data Report* [6].
- ADAP client data for the state of Maryland (2021) are not included in this report or the accompanying tables because the data were unavailable at the time of publication.
- NASTAD (formerly known as the National Alliance of State and Territorial AIDS Directors), a national partner organization, also publishes an annual report, the *National RWHAP Part B ADAP Monitoring Project Annual Report*, which places the ADAP structure, budget, and service utilization within the broader RWHAP Part B system. NASTAD’s report is based on aggregate-level, point-in-time data that NASTAD collects directly from the RWHAP Part B and ADAPs. Therefore, the information presented in this *RWHAP ADAP Annual Data Report*, based on client-level data across the calendar year, may differ from the information presented in NASTAD’s report.

TECHNICAL NOTES

The *Ryan White HIV/AIDS Program AIDS Drug Assistance Program (ADAP) Annual Data Report (ADR)* is the Health Resources and Services Administration (HRSA) HIV/AIDS Bureau's (HAB's) primary source of annual data to evaluate the reach of ADAP on a national level. The ADR allows HRSA HAB to describe individuals enrolled in the program, the ADAP-funded services being used, and the costs associated with these services [4].

The ADR was developed and implemented in 2013. Ryan White HIV/AIDS Program (RWHAP) Part B ADAP recipients in the 50 U.S. states, the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands are required to submit ADR data as a condition of the Part B grant award (the remaining five U.S. Pacific territories do not have this requirement). The ADR consists of two components: (1) the Recipient Report and (2) the Client Report. The Recipient Report is a collection of information about ADAP administration, funding, and policies.

The Client Report is a collection of de-identified client data that includes each ADAP client's basic demographic data, enrollment and certification information for clients enrolled during the calendar year reporting period (January 1 to December 31) [4].

Although the ADR may include clients who used both ADAP and non-ADAP RWHAP services during the reporting period, ADR data do not include information on non-ADAP RWHAP services (e.g., outpatient ambulatory health services), nor does the ADR collect information to identify which clients overlap with non-ADAP RWHAP services. De-identified client data from non-ADAP RWHAP services are reported through another data system and are published annually in the *RWHAP Annual Data Report* [6].



PRESENTATION OF DATA

The data in this report include information received by HRSA HAB for all ADAP clients during calendar years 2019–2023. The purpose of the client demographics is to describe the sociodemographic characteristics of all clients **enrolled in ADAP, regardless of whether they used services** (i.e., a client can be enrolled in ADAP but not use a service) [4].

- Tables 1–6: National-level data—Numbers and percentages of ADAP clients, presented by year, selected demographic variables, and ADAP (i.e., non-RSR) services used
- Tables 7–12: State/territory-level data—Numbers and percentages of ADAP clients by state or territory, presented by selected demographic variables and ADAP (i.e., non-RSR) services used

Tables 1–6 display subtotals and the overall totals for each subpopulation. The subtotals are displayed to reflect the denominator used for the percentage calculation of each subpopulation. In some cases, percentages may not sum to 100.0% due to rounding. Due to missing data, the values in each column may not sum to the column total.

ADAP Clients

To be eligible to receive ADAP services, a client must have a documented diagnosis of HIV, have low income (as defined by the recipient; may be determined based on percentage of the FPL), and meet the residency criteria established by that jurisdiction's ADAP [7]. An ADAP client is any person who is certified as eligible to receive ADAP services during the reporting period, regardless of whether the person used ADAP services during the reporting period. In the event of a funding shortage, clients may be placed on a waiting list; however, in 2023, there were no ADAP waiting lists. A newly enrolled ADAP client is a client who has enrolled in the state's ADAP during the reporting period for the first time ever [4].

Age Group

ADAP recipients are required to report the ADAP client's year of birth. This information is used to calculate the client's age during the designated year as a discrete variable. For tables displaying age groups (Tables 1–6), client ages were categorized to align with the Centers for Disease Control and Prevention's National HIV Surveillance System age group delineations. The age group delineations are as follows: <13, 13–14, 15–19, 20–24, 25–29, 30–34, 35–39, 40–44, 45–49, 50–54, 55–59, 60–64, and ≥65 years. In Table 8, client ages were categorized using broader age group delineations: <13, 13–24, 25–34, 35–44, 45–54, 55–64, and ≥65 years.

Race/Ethnicity

ADAP recipients reported race/ethnicity information for ADAP clients according to the Office of Management and Budget (OMB) reporting standards from the reporting year. The OMB standards have five categories for race: American Indian or Alaska Native, Asian, Black or African American, Native Hawaiian or Other Pacific Islander, and White. Data on ethnicity have two categories: (1) Hispanic or Latino and (2) not Hispanic or Latino. Race and ethnicity are submitted as separate variables and combined for analysis. In the analysis, the race/ethnicity variable is categorized as American Indian or Alaska Native, Asian, Black or African American, Hispanic or Latino, Native Hawaiian or other Pacific Islander, White, and multiple races (two or more categories of race reported).

In this report, clients categorized as Hispanic/Latino may have had race reported as well. Clients categorized by race (e.g., Black/African American) are non-Hispanic/Latino; however, the number of clients reported in each “non-Hispanic/Latino” race category may include clients with missing data for Hispanic/Latino ethnicity.

ADAP recipients are expected to make every effort to obtain and report race and ethnicity based on each client's self-report. Self-identification is the preferred means of obtaining this information.

Sex

ADAP recipients reported client's sex based on client self-report of their assigned biological sex at birth; the response categories were Male and Female.

Federal Poverty Level

FPL characterizes the client's annual household income as a percentage of the FPL at the end of the reporting period. The poverty levels were categorized as 0–100% FPL, 101–138% FPL, 139–250% FPL, 251–400% FPL, and >400% FPL [8].

Health Care Coverage

ADAP recipients report all sources of health care coverage that each ADAP client had for any part of the reporting period, regardless of whether the ADAP paid for it. Health care coverage was categorized as private employer, private individual, Medicare, Medicaid, Medicare and Medicaid (dual eligibility), Veterans Administration, Indian Health Service, other plan, multiple coverages, and no coverage.

The Medicaid classification also includes the Children's Health Insurance Program (or CHIP) and other public state health care coverage programs. The Medicare Part D classification is a stand-alone prescription drug coverage insurance for clients on Medicare. Medicare Part C (or Medicare Advantage Plan) is another Medicare health plan choice offered by private companies approved by Medicare that offers Part A, Part B and Medicare prescription drug coverage (Part D).

States and Territories

State data are displayed in Tables 7–12. Clients enrolled in ADAP in multiple states are not de-duplicated and are included in each state’s data; however, these clients make up less than 1% of all ADAP clients. In addition, data presented by state include data for all clients served by state ADAPs regardless of the source of ADAP funding used.
